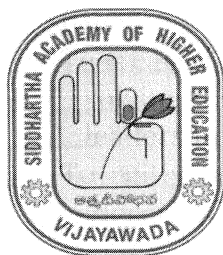

Suggestions:

Dr. P. Udaya Bhaskar, UGC nominee and former Chairman of A.P.P.S.C, suggested to follow UGC guidelines when appointing a Registrar. He further recommended to prepare University Administrative Manual for smooth governance. Additionally, he was also interested to know about the regulations and eligibility criteria for full-time and part-time Ph.D. programs.

Dr. A.V. Ratna Prasad responded that the regulations for admitting Ph.D. scholars are yet to be finalized and will conform to UGC norms and those of reputed universities. These regulations will be submitted to the Board of Studies (BOS) and Academic Council for approval. He assured that UGC guidelines are strictly adhered to in the appointment of the Registrar.

Dr. N. Siva Prasad proposed including a course specializing in Cyber Law within the Masters of Law due to its current high demand.

Dr. A.V. Ratna Prasad mentioned that our institute has a MoU with National Forensics University, Ahmedabad, and is establishing a Cyber Security Laboratory in the Computer Science and Engineering department. Furthermore, the University is introducing a new course, M. Tech in Cyber Security, starting from this academic year. We can plan to start the Cyber Law course in ML in the coming years.

- ❖ The Date & Time for counseling will be intimated to the candidates either by SMS or E-Mail or displayed in the University Website.
- ❖ Change of Date & Time of counseling is generally not permissible. If a candidate fails to appear personally for counseling on the Date and Time specified, he / she will forfeit his candidature for the allotment of seat on that day. However, he / she is eligible to appear for subsequent counseling depending on the availability of seats.
- ❖ The candidates should produce the required documents in originals along with one set of photocopies while reporting for counseling. Candidates will not be allowed to participate in the counseling process without the documents.
- ❖ Provisional allotment will be given on merit basis through counseling for B. Tech, B. Com, B. Sc., LLM, M. Tech, MBA, MCA and Ph. D.
- ❖ Details regarding Number of seats in a program, eligibility qualification, fee structure etc., will be displayed in the University website.

Fee refund norms against cancellation of admissions

- ❖ Admission fee is non-refundable.
- ❖ The Tuition Fee will be refunded to the candidates in accordance with UGC guidelines.

Important points to note

- ❖ No candidate shall be eligible to register himself / herself for a full - time program of study if he / she is already registered for any full - time program of study in this University or any other University / Institution.
- ❖ Important Dates related to the admission are announced through either print media or electronic media or displayed on University website.
- ❖ The University shall have the right to cancel the admission of any candidate for false submission of facts pertaining to qualifications, reservations and any other matters.
